aforesaid Planter do assign sell and sett over unto John Barnard of the City of St. Marys Inholder  
one man servant called John Ward who hath from the day of the date hereof twenty two moneths  
to serv to the compleating and finishing of his time of service, I the said Timothy do assign over  
unto the said John Barnard all my right title and Interest of the said John Ward to have & to  
hold the said John Ward to him the said John Barnard or his assigns during the same  
aforesaid termes my hand & seal the third day of January Anno Domini 1679

This Indenture the twelfth daye of January in the fifth year of the Dominion of Charles absolut: Lord and Proprietor  
of the Province of Maryland and Anthon: Lord Baron of Baltimore or his trust William Gwyther of Saint  
Helens in the County of Saint Marys Gent of this our part and Elizabeth Da Costa late of the same place  
County of the other part witnesseth that he said William for and in consideration of the summe of five  
thousand pounds of tobacco to him in hand paid whereof and to be discharged he shall pay to be fully  
satisfied accounted and paid and herof and every part and parcel thereof doth hereby Exoneraled acquite  
and discharge the said Elizabeth Da Costa her heirs Executore & Administratores hath given granted  
bargained sold Alured Esposito and Ensignes and by these presents doth hereby give Grand Bargaine sell Mie  
Esposito and Ensignes unto the said Elizabeth all that Myssegi or demesne called Hogg No 83 Part of Saint  
Helens hundred where the said Eliz: Da Costa now lieth in Saint Helens aforesaid bounded on the South  
with the land lately by the said Within sold to Robert Mason of St. Michaels Hundred in this County aforesaid  
And beginning at the west end corner end of the said Robert standing by the said side which lyeth between  
the house of the said Within and the house of Thomas Griffin and Elias Booth and running by the said  
Loud up to the mouth of Little Run or branch that falleth into the said Land from the back way that lead  
from Saint Helens aforesaid up to that part of Saint Elizabeths Manoe where John Barber lies and  
from thence by the winding of this said Run up to the said Earth and from that Earth by the winding  
of the said Run up to the head end of the said hundred and then by the said Headend till it leades for  
the said Land or Doores of the said Robert Mason containing by estimation two hundred acres  
be it more or less together with all houses Edifices Buildings Orments houses Woods Underwoods to  
the said Demense called Hogg No 83 belonging or appertaining and all other Profitts Goods fitte &  
Emoluments arising and accruing or hereafter to arise or drawne out of the said Lands or any the  
aforesaid premises to him and to hold the said Land & house Edifices Buildings Orments houses  
Woods Underwoods and all other the aforesaid premises to her the said Elizabeth Da Costa  
and her heires and executors for ever free and clear and freely Exoneraled and discharged  
from all singular or any former Bargaines sales Judgements rents charges rents arrears of  
rents or other Jurumbrans by him the said Within had made suffered or done yelding and  
paying to the said Within his heires and executors yearly and every year at the feast of the  
Vestry of our Lord his full and just quantity of two bushells offifts Indian corne lawfully  
drawnd upon his aforesaid Premises did the said Within Gwyther for him his heires  
Executors and Administratores dole Covenant grant to and with the said Elizabeth Da Costa her  
heires and executors that he the said Within his aforesaid lands or Demense called Hogg  
not be with all his aforesaid premises to her the said Elizabeth and her heires & executors  
will for ever warant against him the said Within and his heires and executors any and all persons  
claiming by from or under him them or any of them in witness whereof the parties to these present  
Indentures have lawfully set their hands & sealed the day and year first above written
