Whereupon the said John Burdett by Robert Ridgely his Attorney prayed that the aforesaid Goods together with One thousand & Sixty pounds of tobacco formerly attached in the hands of Henry Hozier might be committed unto him upon giving security according to Act of Parliament in that behalf made & provided and it is granted by the Court here.

Now here at this day so with the fourteenth day of March in the year aforesaid came the said John Burdett with Michael Miller his Juror, who undertook for the said John Burdett in the sum of twenty nine pounds & one penny ster, to indemnify this Court against all the aforesaid Attachments and shall make restitution of the aforesaid Goods & tobacco or of the value thereof (except Sheriff's fees for Attaching the same) in case the said Thomas Digges or his Attorney shall within one year & a day make his just & due defect to the aforesaid action of the said John Burdett, & proceed on in the said action in common form and make it appear that the said John Burdett is satisfied his just demands. Whereupon the Court condemned the Goods & tobacco so attached as aforesaid and ordered that the Sheriff of Kent County aforesaid deliver the same unto the said John Burdett.

Know all men by these presents that Barnaby Duntz of London Merchant have assigned ordains made and constituted, and by these presents doo assigne ordains make constitute my Loving Brother Walter Duntz of Lincolne in the parish of St. Dunstons in the County of Middlesex My true and Lawfull Attorney, for mee in my name and to my use to Demand sue for Levy recover and recover of and from Colton Will in Wynd and off Richard Hill and of all and every other person and person whatsoever Inhabiting within the Countie of Meryland and of theire Executors admors and assigns, All and every sume & debt and debts summe and summe of money goods wares Merchandises and Chattells whatsoever now due or hereafter to growe due or payable unto mee from or by reason of any bond bill booke specialty account or otherwise whatsoever in any kind & nature or manner whatsoever or howsoever, And I doo hereby grant and give unto my said Attorney my full and whole power and authority to use all such lawfull waies and meanes in and about the executing of this premises as to my said Attorney or his assigns shall seeme meet and convenient, And upon the receipt of the said debts summe of money goods wares Merchandises and Chattells or any of them or any part thereof Acquittances or other reasonable discharges for mee and in my name to make seals and deliver for this same And all and singular other act and acts thing and things doo and dooers in this law whatsoever needfull or necessary to be done in or about the execution of this premises in my name to doo execute and performe as fully and effectually as I my self might or could doo word & personally present to all intents and purposes; and one Attorney or more under him to make & substitute and the same at pleasure to revoke All which and whatsoever my said Attorney & his
