 prosecute and perform the same, and our Attorney or more under him to make and
 fulfill the same at pleasure to revoke, Alter and whatsoever of my
 said Attorney or his substitutes or assigns shall Lawfully do or cause to be
 done in or about the Execution of the promise by virtue of the power
 I do have and will ratify Confirm and Allow by the said power, In witness

 other Commodities due to mee from any person or persons whatsoever within the Province of
 Maryland or Colony of Virginia, and upon default or refusal of payment of any debt or
 debt due to mee and aforesaid I do hereby empower my said Attorney to sue and implead or
 by any other Legall way Recover all such debts as shall not be paid or due payment
 by any person or persons whatsoever as aforesaid, And I do hereby authorize my said Attorney
 to constitute and appoint one Attorney or more under him for the good management and to receive
 Recovery of all and singular my debts as aforesaid, hereby ratifying and allowing all whatsoever
 my said Attorney shall Lawfully do or cause to be done in and concerning the premises to be
 done and fulfilled as fully and effectuallly and in as ample manner as I should
 and purpose as my selfe might or could do were I personally present and did act
 prosecute and perform the same, In witness whereof I have hereunto set my hand and seal
