Whitehaven y 4th Dec 1679

I resolved by Gods help to have seen you once againe at St. Georges that we might have us fully ended & tedious affairs. But I am for mispossed wth the remaines of the Maryland charge that I dar. not as yett venture upon such a voyage, I hope first will find y^e and all yo^r in good health, and y^e y^e trade or will before the returne of y^e ship that brings this to yo^r hands pay to Mr. Peter Watto or order y^e just ball of y^e Account of the Tobatto now for long due to yo^r. Bro: Mr. Addison that a Brotherly correspondence may still be kept up amongst y^e, you may remember & your owne aff^s will shew you that the Ballance was att^d. amounting to

Soe there will rest due from you in all 21883

Since I cannot be with you, I doubt not but you will assist Mr. Watto in seeing the Tobatto ship, the trouble given by old Gale both to yo^r. Bro Thomas & Bro: Henry will force them to depend of y^e Tobatto by your due, this year: which I hope you will not fail to pay and then I am satisfied. You may command any thing in reason from either of them or any of yo^r. Relations here though they take it unkindly that you have not writ to any of them having soe good an opportunity there will be some Tobatto due to you w^{ch}. I trusted me with all but w^{ch} it is I knowe not I rest in Mr. Woods hands who has promised to send y^e the Products of it in Goods according to yo^r. ord^r. to me: I am soe weary w^{ch}. business y^e I cannot writ to all large new affairs more
