

*By This public Instrument of Procurator or letter of Attorney be it knowne & manifest unto all People That on the Twentieth day of the month of July Anno Domini 1630 English stile Before me Wm Story Notary and Tabellion publick by authority of our Sovereigne Lord the King admitted and sworn dwelling in the City of London, and in the presence of the witnesses aforementioned personally appeared William Rousby of London aforesaid Merchant into me Notary both knowne; And hath made ordyne and his stead and place hath putt and constituted, and by these presents hath made ordyne and in the place and stead hath putt and constituted Christopher Rousby of Maryland in part beyond the Seas Merchant his true and lawfull Attorney, giving unto him full power authority & speciall charge For and in the name and to the use of him Constituant to aske demand sue for recover and receive of and from Thomas Bowdell of Maryland aforesaid, Planter, or of his heirs Executors Admors or goods or such others whom it shall or may concerne all and singular summes and kinds of money, Debts, Effects and things whatsoever as the said Thomas Bowdell hath owe and is indebted to the said Constituant; For the same by Book Obligation, Specialty, account or otherwise nothing excepted nor reserved, with all costs damages and interests. Also to attempt with the said Thomas Bowdell, and to receive what due by Ballance. And if neede shall require to compound and agree; And any thing in difference to submit unto and determine by way of Arbitration. Of the recoveries and receipts to make and give due acquittance and discharge. And if necessary for the said Constituant to appear & the person to represent in all Courts and before all Lordes Judges and Justices, and to doe say pursue plead seize sequester attain arrest imprisonment and to tender and out of Prison againe (when neede shall be) to deliver *facultate substituendi* and generally in concerning the premises and the Dependours thereof to doe say transact and accomplish all and whatsoever the said Constituant himself might or could doe personally. Although the matter require more speciall authority than herein is comprized. The said Constituant hereby promising to have hold also to ratifie and confirm for good and of ballance for ever all and whatsoever his said Attorney or his substitutes shall lawfully doe or procure to be done in & about the premises by vertue of these presents. In witness whereof the said Constituant hath hereunto putt his hand and seal; and these presents for and as his Act and Deed have delivered in the presence of mee Notary, and of Thomas Broockhouse and Porter Paul both knowne.*

Know all men by these presents that Christopher Rousby hath by vertue of his letter of Attorney within mentioned unto of Thomas Bowdell in the letter of Attorney named the Twentieth day of November 1630 for the use and behoofe of y^e within named William Rousby the Constituant due bill obligatory bearing date with these presents signed sealed & delivered by the said Thomas to the use of the said William Rousby the said Thomas Bowdell doth oblige himself his heirs Executors & Admors to pay to the said William Rousby his Executors and Admors or retainers Attorney the full summe of fifty pounds sterl money of England. Wherof fifty pounds I the said Christopher Rousby Attorney or Depts attempt & demands whatsoever due from the said Thomas Bowdell to the said William Rousby from the beginning of the world until the time of the sealing & delivery of the said bill by the said Thomas to the use of the said William as aforesaid.
