

 Mr. Simon Wimber of Virginia Merchant his ffre and lawfull Attorney Goynge unto
 hym full power authority & speciall charge for and in the name and to his
 use of hym sufficient to affe demand recover and receive of and from his heires
 Executores Administratores or goods of Mr. Nathaniel Stiles late of Virginia deceased
 or of any other person or persons whome it or right doth or may concern all
 and singular summe and sumes of money debtes goodes wares & barretors
 merchandises effects and things whatsoeuer as the said Nathaniel Stiles,
 when living did and as his estate whiche he left behinde him doth owe and is
 indebted and stande atcomptable unto hym sufficient therif by bill booke
 obligacion speciall acount covenant contract promise or otherwise
 by any wayes or meane whatsoever nothing excepted nor reserved with
 all costes damages and intereate, also to compound and agree and to a
 acount with or take account of any person or persons whatsoeuer concerning
 the p'ncesse. Of the recoverye and receipte compositions and agreements
 acquittances or other sufficient discharge in the name of hym sufficient to
 make subscribe Seale and deliver. And if needfull to appear, and the person
 of the said Sufficiant to represent in all causes and before all Lordes Judges
 and Justices and to doe say purfue in plead brye sequer attaint
 arrest imprison and to condigne, and out of prison againeswheneued
 scallber to deliver hym facultate substituendi. And generally in
 and concerning the p'ncesse and the dependentes thereof to doe say transact
 and accomplish all and whatsoeuer the said Sufficiant shalfe might or
 could doe personally, Althoough the matter required more speciall authority
 then herein is comprised. The said Sufficiant hereby promising to have
 and hold also to ratifie and confirme for good and of valles for ever
 all and whatsoeuer his said Attorney or his Substitutes under hym shall
 lawfully doe or procure to be done in and aboue his p'ncesse by vertue of
 these presentes. In witness whereof the said Sufficiant hath hereunto putt
 his hand and Seale, and these presentes for and as his Att and Deed his
