

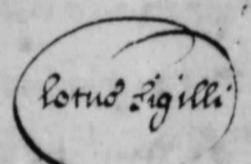
And thus made ordeyned and in his place and stead, hath putt and constituted and by
 these presents hath made ordeyne and in his stead and place hath putt and constituted
 Mr. Simon Wilmer of Virginia Merchant his true and lawfull Attorney Giving unto
 him full power authorize & speciall charge for and in his name and to the use
 of him Constituant to aske demand recover and receive of and from his heirs
 Executors Administrators or goods of Mr. Nathaniel Stiles late of Virginia deceased
 or of such other person or persons whom it or right doth or may concern all
 and singular such summe and Summes of money debts goods wares Robottos
 Merchandises Effects and things whatsoever as the said Nathaniel Stiles,
 when living did and as his estate which he left behind him doth owe and is
 indebted and stands accountable unto him Constituant, be it by bill booke
 Obligation speciall or account covenant contract promise or otherwise
 by any wayes or meanes whatsoever nothing excepted nor reserved with
 all costs Damages and interest, also to compound and agree and to
 account with or take account of any person or persons whatsoever touching
 the premises. Of the recovery and receipts compositions and agreements
 acquittance or other sufficient discharge in his name of him Constituant to
 make subscribe seal and deliver. And if needfull to appeare, and the person
 of the said Constituant to represent in all Courts and before all Lordes Judges
 and Justices, and to doe say pursue implead seize sequester arreare
 arrest imprison and to condempne, and out of prison againe when need
 shall be to deliver *plena facultate substituendi*. And Generally in
 and concerning the premises and the dependences thereof to doe say transact
 and accomplish all and whatsoever the said Constituant himselfe might or
 could doe personally, although the matter required more speciall authority
 then herein is comprised. The said Constituant hereby promising to have
 and hold also to ratifie and confirme for good and of vantage forever
 all and whatsoever the said Attorney or his Substitutes under him shall
 lawfully doe or procure to be done in and aboute the premises by vertue of
 these presents. In witness whereof the said Constituant hath hereunto putt
 his hand and Seal, and these presents for and as his Act and Deed hath
 delivered in the presence of me Notary and of Thomas Brookhouse and
 Porten Paul witnesses.
