 And in case of his decease and from and after his decease then Nathaniel  
 Heathcote merchant now in Maryland to be my true lawfull full and absolute  
 Attorney and Assignee, for me and in my name, and to and for the attempt  
 and behoofe of mee the said Priscilla Holland my Exors. Administrato<sup>r</sup>. and  
 Assignees to demand recover and receive by course and order of law or otherwise  
 as the place or occasion shall need admitt of or require, of and from all and  
 every or any person or persons whatsoever either in Maryland or Virginia  
 or else where beyond the seas, all and every or any summe or summes of money  
 debts rights credits and things whatsoever which they every or any of them  
 is or are indebted or ought to pay render give or deliver either unto my  
 said late father (if living) or unto me the said Priscilla Holland as his Adm<sup>r</sup>.  
 whether the same be by or upon any bill bond specialty attempt retenuing  
 agreement or otherwise for or upon any matter cause or occasion whatsoever  
 or howsoever And to call to account and account with all and every or any  
 such person or persons as aforesaid. And also to Overseer order and dis-  
 -pose of all or any such goods merchandize servants and other things -  
 late of my said father and now of me, as are now in the hands disposicion  
 or power of the said Simon Wilmer or shall come hereunto or to the hands  
 disposicion or power of the said Nathaniel Heathcote in case of the death of  
 the said Simon Wilmer And the said  
 Priscilla Holland doe hereby give and graunt unto the said Simon Wilmer  
 or in case of his death, then unto the said Nathaniel Heathcote full power &  
 authority as need or occasion shall be or require, to arrest sue pursue  
 implead attach seize condemn imprison and out of Prison to deliver And  
 to receive compound and agree, and all fitting and needfull receipts  
 acquittances releases and discharges to make and give, and to require  
 and receive, And one Attorney or more to make and ordeyne, and the  
 same at pleasure to revoke And generally to doe performe and fulfill  
 for me and on my behalf and as occasion shall be all and every other  
 act matter and thing whatsoever which can or may be done or performed  
 by an Attorney or Assignee, as amply and with as full effect as I may might  
 or could doe performe and fulfill the same if I were personally present And  
 lastly I doe hereby consent unto, allowe, ratifie, and confirme all and  
 whatsoever either of my before named Attorneys, or any person or person  
 to be by him lawfully deputed or authorized shall doe or cause to be done  
 by vertue of these presents or of any power or authority derived herefrom  
 In witness whereof the said Priscilla Holland have hereunto sett my hand & seal
