

To all that shall see these presents or have them to be read I Francis Staplin a Knight Lord Mayor and the Aldermen or Senators of the City of London send greeting Wee doe hereby make knowne and Certifie that on the day of the date hereof in the Kings Majesties Court holden before us in the Chamber of the Guildhall of the said City personally came and appeared Priscilla Holland of London Spinster daughter and Administratrix of all and singular the goods, Chattels, rights, debts & credits of James Holland late Citizen and Grocer of London deceased And declared before us that for doing and performing sundry matters and things mentioned and concerned in the letter of Attorney herunto annexed bearing date the Twelfth day of October instant, she had made authorized and appointed Simon Wilmer now in Maryland late Sergeant at Law for her said father in Maryland and Virginia And in case of his decease and immediately herefrom Chen Nathaniel Heatterot Merchant in Maryland aforesaid his true and lawfull Attorney and Assignee And for more Evidence and confirmation hereof the said appeared Priscilla Holland did before us seal and deliver as her act and deed to the use and for the purposes aforesaid the same letter of Attorney And humbly besought us to authenticate the same to the end it might take effect for the purposes therein and hereby mentioned and intended Wherefore wee have made this Attestation and declaration hereof And in further Testimony have caused the Seal of Office of Mayoralty of the said City of London to be putt and affixed to these presents Dated in London the Twenty first day of October Anno Domini 1678 And in the first year of the reign of our Sovereign Lord Charles the second by the grace of God King of England Scotland France and Ireland Defender of the Faith &c

To all such people to whom presents shall come Christopher Rowley of Calverly County in the Province of Maryland gent. send greeting in the Lord god everlasting Mercies I am designed by gods provision to make a Voyage & finally for England, and so to returne to the Province, and do think it very needfull in my Absence to put some person in Especiall Trust for my Affairs here in Maryland shewell in Relation to my Office of Collector of the said Province & duty due in Maryland aforesaid as also in Relation of my own private Trade & Concerns within the said Province Therefore know ye that the said Christopher Rowley has made Constituted ordaind authorized, and in my place by these presents has appointed and put my very Loving friend Robert Redgely of St Marys County in the Province aforesaid gent. my true & Lawfull Attorney and Counsellor, for me and in my Name to my use to Aske require receive receive, sell & singular Summs of Money Tobacco goods Chattels &c due & demanded Demandd whatso ever they be of all person & persons in anywise due to me within the Province of Maryland & WELM and granting unto my said Attorney my full Power & Lawfull authority for the Recovery of the said Summs of Money Tobacco &c demanded
