

And Duty To arrest the Impression of Condemnation all and every such
 person or persons as shall die or do not upon demand pay or satisfy all
 such kind of Money Tobacco &c. and Duty to do as in any writ due unto me
 And Upon Receipts of the same Lawfull and Respectiv. acquitances of other
 sufficient discharge for me and in my Name to make such Provisions, & to
 appear for me and defend me in all and every Court, and Courts within the
 Province in all Quon or account suits or suits that are or shall be found
 against me by any person or persons whatsoever, And one or more Attorney or
 Attorneys and him to make, and as the Estates against to Revoke, And
 Whereas I have for the better Managing of my said Office or place of
 Collectors of the said Duty aforesaid, substituted Lawfull Deputy for the
 Lawfull and Respectiv. Duties within the Province, I do hereby empower &
 authorize my said Commission and Attorney to require Return of all such
 every the accounts and accounts of my said Deputy of every of them, and to allow or
 discharge thereof as the case shall require, and as to my said Attorney shall
 seeme Right, just and convenient, And also to have access my said Deputy or
 any of them upon any reasonable Cause or Causes at the direction of my said
 Attorney to displace & put out of Service and Office, and in such Case or Cases
 as shall be of Mortality or any other case whatsoever Whereby any vacancy
 or may happen to be in the place of Deputy Collectors in any Duties port whatsoever
 within the said Province of Maryland to Re-appoint substitute authorize employ & put in
 such other person or persons to officiate in such Vacant Place or places as to my said
 Commission and Attorney from time to time shall seeme Meet and convenient, Also
 granting to my said Commission or Attorney full power to sell and Dispose of for my
 profits use and benefit, all such goods Chattels Household stuffs Corns grained &
 other things of and belonging to in the said Christopher Lewby within the said Province
 as from him to him my said Attorney shall thinke fit, Also granting to my said
 Commission and Attorney full power and authority in my Name On behalf of the
 Majesty of our said Lord the King, the Governour of this Province for the time being
 and myself to exhibit file and prosecute in the effects in any Court or Courts within
 this Province all and every Informations & Informations that shall be in the direction of
 my said Commission and Attorney to be exhibited filed & prosecuted, against
 any person or persons, Whipp or Whippo, Vessel or Vessels, goods Merchandize or other
 things whatsoever After Condemnation thereof for breach of the any private statute
 of England Touching or Concerning Navigation or the Majesty's Customs, And the
 said Whipp or Whippo Vessel or Vessels, goods or Merchandize or other things whatsoever
 After Condemnation thereof for breach of the private Laws aforesaid the same to sell and
 Dispose of at pleasure in as large and ample manner as if I were personally present to
 doe and performe the same, and of the Negro and my part thereof to make as full
 & sufficient Warranty thereof as I could doe if present, by my Commission, And also to
 suppress & impede all and every person or persons that are or shall be found
