Resignm<sup>t</sup>. or otherwise nothing excepted or reserved And also to possess & recover to our use & use all summe & summe of money, Goods, wares, merchandises Effects & things whatsoever in Maryland aforesaid belonging or due to us or either or any of us joyntly or severally And more especially to recover & receive our Debts & due lands Plantations stock Negroes Cattle & servants that are or may be in the hands Custody or possession of any person or persons whatsoever Debts & Debts due or due to us or either or any of us joyntly or severally of the said William Parker Esq. late of St. Pauli And upon non payment refusal or delay of any Debts or due of possession or satisfaction thereof of the said person or persons Debts & Debts due or due to us or either or any of us joyntly or severally & to possess & recover to our use & use of our Constables or any of us joyntly or severally as aforesaid. Likewise empowering our said Attorneys & Promoters joyntly & severally to bargain sell alienate assign or exchange make of sell or for more lands plantations or Divid<sup>nts</sup> to us or any of us belonging according to order and devise from us from time to time received And upon such Sale alienation or exchange to pass & make such Deeds & writings as by law shall be required & reasonably advised or required And from time to time by the said & best opportunity possible to make returned to us into England of the produce and proceeds of the same or any part thereof with just and true accompt
