

lying and being in Falset County aforesaid on the west side of Shantuck River upon
 the first said Beginning at a marked Oak near a byre or Barn and running North up
 the River for hundred and fifty paces unto the bound tree of same &
 being land bounding on the North with a line drawn west from the said Street for the

 decaies the one third part of the same lands during her natural life) together
 with all rights profits benefits advantages and appurtenances whatsoever there
 unto belonging to have and to hold the said lands (except before excepted) and
 all other the premises hereby granted bargained sold or intended to be granted
 bargained and sold and every part and parcel thereof with all and singular their
 and every of their appurtenances unto the said Numan Bratton his heirs and —
 designed forever to the only proprieuty and benefit of him the said Numan —
 Bratton his heirs and designed for ever And the said Isaac Foxcroft and —
 Bridget his wife for themselves their heirs Executors and Administrators and attorney
 of them doth covenant promise and grant to and unto the said Numan Bratton his
 heirs Executors and designed and every of them by these presents in manner
 and form following vizt That the said Isaac Foxcroft in his own right
 is and standeth lawfully seized of a good perfect and absolute Estate, in law
 in fee simple of and in the said parcel of lands and other his premises with
 their appurtenances, and that he hath a lawfull Right and authority to —
 bargain sell and assure the same unto the said Numan Bratton his heirs and —
 designed for ever according to the manner of these presents and that the
 said land and other his premises with their appurtenances now are and for ever
 hereafter shall be and continue to be discharged and acquitted of
 all taxes and all manner of poundage by the said Isaac Foxcroft and Bridget
 his wife his heirs Executors and Administrators of and from all and singular
 former grants bargains sales estates bonds Statutes Injunctions Decrees —
 Charters of Surveyors, rents charges offights, and other charges and
 impositions whatsoever held made or done or to be had made or done by or
 from the said Isaac Foxcroft or Bridget his wife or by any other person or —
 persons having by him or under him or either of them or by his or either of
 them or procurement had the said Isaac Foxcroft and Bridget his
 wife his heirs Executors and Administrators will warrant and defend the same (except
 before excepted) unto the said Numan Bratton his heirs and designed for ever
 against Thomas Clegg and Sam: his wife of the colony of Virginia aforesaid
 his heirs Executors Administrators and designed and all other person or persons
 whatsoever. And further that the said Isaac Foxcroft and Bridget his
 wife
