

This Indenture Witnesseth that Patrick Gormuch aged about twenty seven years
 from the Kingdom of Scotland Accountant Not contracted to any other service but
 his own at the own disposal and voluntary service do put himself a servant
 and do Covenant by this present to and with Stephen Mitchell Merchant to faithfully
 serve him the said Mitchell or Assignee from the day of the date hereof until the first
 and next Christmas in the land of Virginia and after for and during the term
 of four years in full time or sailing time, or for any such employment
 as the said Stephen Mitchell or Assignee shall employ him according
 to the Custom of the Country In consideration whereof the said Stephen Mitchell
 for himself the said Mitchell and Assignee doth Covenant promise grant and agree to
 & with the said Patrick Gormuch to pay for his passage in the good Ship
 the Experiment Capt James Long Leonard or in any other Ship whithersoever
 bound by the Order and direction of the said Stephen Mitchell or Assignee
 and also to feed and provide him with Meat Drunk apparell washing and
 Lodging during the said term And in the end of the said term the said Gormuch
 servant shall have all such Allowance of apparell provision & other necessary
 as to others are allowed given and granted according to the Custom of
 the Country the present delivered and paid to the use of the said Gormuch on board
 the said Ship and one shilling money as a gift for that he shall provide & serve
 according to the true meaning of the said Indenture and the Act of
 Parliament made and provided in that behalf, And in case the said
 Patrick Gormuch shall not provide the said voyage by any dislike the
 said Mitchell or Assignee and warrants to repay back again to the said Stephen
 Mitchell or the order all such money layd out for him for the said voyage and for all
 other charge without fraud or receipt And for the true performance of all and
 every the Covenants and agreements herein contained either party to the other bindeth
 himself by this present In witness whereof the party aforesaid have subscribed
 their names Interchangeably set their hands and seals the day of the date
 Day of October 1602.
