 Deed; And the within mentioned Land therein bargained and are the right of the within named
 Henry Brent and his heirs forever also at the same day and time some Mary the wife
 of the within named Georg Yate and doth stand that she gave her consent to the sale of the
 within mentioned Bargained Land and Premises freely and voluntarily and willingly without any
 form or fear of the displeasure of her said husband and that she did fully freely and absolutely
 acquit and release the said Land and Premises of all claims of her title of Dowry and of all
 other right or demand of in or to the same forever taken before us the day and year afore said.

 Merchantable Lawe to be paid to the said Henry Brent or to his
 certain Attorney Esq^r Adam For design^d To the use of payment well and truly to be made
 and done I bind my self my heirs Esq^r and Adam firmly by these presents In witness
 whereof I have hereunto set my hand and seal the thirteenth day of December
 in the eighth year of the Dominion of the Right Honble Charles Lord Baltimore and
 in the year of our Lord God One thousand Six hundred Eighty and Two. /

The condition of the above written obligation is such that if the above bounden Georg Yate his
 heirs Esq^r and Adam and every of them do and shall from time to time and at all times
 hereafter well and truly observe perform fullfill and keep all and singular the above written
 grants Articles clauses and agreements mentioned contained and expressed in one certain
 Indenture of Bargain and sale or Deed made between the above bounden Georg Yate
 of the one part and the above named Henry Brent of the other part bearing date with these
 presents whereon the part and behalf of the said Georg Yate his heirs Esq^r and
 Adam are and ought to be observed performed fullfill'd done and kept and that in all
 and by all things according to the true intent and meaning of the said recited Indenture
 especially in all points and conditions that he or his heirs or assigns are bounden to
 be voyd and of none effect otherwise to stand and remain in full force and vertue.
