 owing belonging or appertaining unto me by any manner of way^s or means what
 soever from any person or persons whatsoever ad also to recover and take possession of
 any partill of tract of land, belonging or appertaining unto me in the said Province of
 Maryland, and in my name to bargain sell lease or grant to such person or persons or
 for such estate for life or lives Inheritance or otherwise and for such sum^s and Sum^s
 of money or Tobacco ad to my said Attorney shall thought meet and convenient to the
 utmost and best Comodity and profit of me the said Edward Perrin and the said Deed
 of the Sum^s, grant & estate ab^l made for me and in my name to seal and ad my said
 Deed to deliver unto the party^s to whom the same shall be made: or any other to their
