 the Caste aforesaid Planter my true and lawfull attorney ad wel for me and in my name  
 and to my own profit and receipt to ask sue for, leby, require recover and recive  
 of all every person and persons whatsoever all gentry Lents & Rents sume and  
 sume of mony & barre, goods wares Merchandize and other things whatsoever as are  
 now due unto me or whiche at any day or dayes & tyme or times hereafter shall be due  
 owing belonging or appertaining unto me by any manner of waye or meane what-  
 soever from any person or persons whatsoever as also to recover and take possession of  
 any partill of tract of land, belonging or appertaining unto me in the said Province of  
 Maryland, and in my name to bargaine sell lease or grant to such person or persons or  
 for such stales for life or lives Inheritante or otherwise and for such sume and sume  
 of mony or barre as to my said attorney shall be thought meet and convenient to the  
 utmost and best commodity and profit of me the said Edward Perrin and the said Deed  
 of the sume, grant & stales oblo: made for me and in my name to Scott and ad my old and  
 Deed to deliver unto his partye to whom the same shall be made or any other to him  
 wch Caste & Counterparte of the same for me and in my name to accept and receive given  
 and by these pres:ntes granting unto my said attorney by vertue & rof full power and  
 absolute authority for me and in my name & to and for my self benefit and commodity to-  
 ast sue for, leby, recover, and recive of all and every person and persons whatsoever  
 & every Lent & Rente sume, and sume of mony & barre goods wares Merchandize & other things  
 whatsoever as are now due unto me or whiche at any day or dayes & tyme or times hereafter  
 shall be due owing belonging or appertaining unto me by any manner of waye or meane &  
 whatsoever from any person or persons whatsoever due upon non payement of any of such  
 deuts & sume & sume of mony & barre goods wares Merchandize and other things for  
 me and in my name to sue, arrest attache & reseizemēt and condicione and out of prison  
 to deliver and to appear before all manner of Judge & Justiced & Ministers of the law  
 and to compounde & compromitt towardes agree, recover & receive, and to ge: acquittant,  
 released discharge, and our Attorney or more under him to make substitute and reweak and  
 generally to do execute prosecute and determine all and every other deit & deits thinge  
 thinge whatsoev'r wch in or about the p'mise d' shall needfull necessary or convenient ad-  
 fully and effectually to all intent and purpos'd as I my self might or could do. If I were  
 there personally present holding and allowing forfme & Scott all and whatsoever my said  
 Attorney the substitute or assignee, shall lawfully doe or cause to be done in or about the  
 p'mise by vertue of these pres:ntes In witness whereof I have setto my hand  
 and seal Dated the thirtieth day of May anno Dom 1681.
