

This Indenture made the Twelfth day of January in the Year of our Lord Christ
 One Thousand Five hundred Eighty Two Between Robert Wright of Calvert County in the
 Province of Maryland Planter of the One part And John Evans of the County & Province aforesaid
 Proprietor of the other part Whereas the said Robert Wright by Letter Patent under the Great Seal
 of the said Province of Maryland bearing date the fourteenth day of April in the thir-
 ty-ninth year of the Dominion of the R. h. C. & the then Lord Prop. &c Annoqz-
 Dni: 1667 had granted unto him a parcel of Land for One hundred and fifty acres called
 Wrights Quaint Leasur - Cutt & bounded as in the said Patent is before And whereas
 also the said Robert Wright by other Letter Patent bearing date the first day of May in the
 51 and thirtieth year of the Dom: of the said Cecilius & had granted unto him another
 parcel of Land for Three hundred acres called Ishmaels Right according to the Cutt and
 bounds mentioned in the said Patent which said two Tracts of Land are said by the said
 Patent to ly adjoyn to one another in Calvert County aforesaid Now this Indenture
 witnesseth that the said Robert Wright for and in Consideration of the full Sum or Quantity of
 Five thousand pounds of Tobacco to him the said Robert Wright will & truly in hand paid the
 Receipt whereof the said Robert doth hereby acknowledge and therewith to be fully satisfied & contented
 and paid and thereof and of every part and parcel therof doth clearly acquit & discharge the
 said John Evans his heirs & Exec. & Adm. for ever by these presents He the said Robert Wright
 Hath granted bargained sold & confirmed and by these presents doth fully clearly and
 absolutely grant bargain & Confirm unto the said John Evans his heirs & Assigns
 for ever All those two several Tracts of One hundred & fifty ~~and~~ and three hundred acres
 of Land & for mentioned called Wrights Quaint & Ishmaels Right with all & Singularity
 Rights numberes and appertaining to the said parcels or any part or parcel therof
 belonging or in any way appertaining And also all the said Right title & interest of him
 the said Robert Wright of us to the same and all Patents Deeds writings & evidences touching
 concerning the parcels or any parcel of them to have & to hold the said two several
 Tracts of Land before mentioned to be hereby granted bargained & sold and all other
 the parcels with the appertaining unto him the said John Evans his heirs & Assigns
 to the only proper use & benefit of them the said John Evans his heirs & Assigns for ever
 And the said Robert Wright for himself his heirs & Exec. & Adm. the said bargained
 parcels to the only proper use & benefit of them the said John Evans his heirs & Assigns
 for ever will warrant defend of from all claimes whatsoever And the said
 Robert Wright doth further covenant for himself his heirs & Exec. & Adm. that he
 the said Robert Wright his heirs & Exec. & Adm. shall & will at all times & times
 hereafter make do performe & execute or cause to be made done performed & executed
 such further & other acts & cates commandes & assurances in the Law for the more perf-
 fect assuring & securing the said parcels unto him the said John Evans his heirs & Assigns and
 assyng as the said John Evans his heirs & Exec. & Adm. shall require by any way
 or means whatsoever that the Law shall require And that the said Robert Wright
 at the time of the sealing & delivery thereof hath in himself a good pure perfect and
 absolute title of inheritance in fee simple of us to the said parcels and that he
 hath good right full power & lawfull authority to sell & dispose of the same and vny-
 part
