 of the same County planter and in case of Mortality or that it shall  
 please God the said Thomas Greenfield should dye, disability or  
 departure out of this Province my truly & wellbelov'd James Keeth  
 of the same County Gent<sup>l</sup> my true & lawfull Attorney for me & in  
 my Name & to my use to Aske sue for, Levy Receive Recover & Recover  
 all & Every such Debt or Debt's Rent's or Arrearages of Rent's Sum's or  
 Sum's of Money Sum's or quantities of Tobacco as are now due unto  
 me or which at any day or Day's time or time hereafter shall be  
 due owing or belonging unto me by any manner of Way's or Means  
 whatsoever from any person or persons whatsoever within the said  
 Province or any other place whatsoever in America Guiana and  
 Granting unto my said Attorney the said Thomas Greenfield & in  
 case of his disease disability or departure out of this Province ad-  
 aforesaid to the said James Keeth by these presents my full & whole  
 power strength & Authority in and about the premises And upon the  
 Receipt of any such Debt's Rent's Sum's of money or Tobacco aforesaid  
 Acquittances or other discharges for me & in my name to make Seals &  
 Deliver and all & Every other Act & Act's thing & things devise & devised  
 in the Law whatsoever needfull or necessary to be done in or about  
 the premises, for the Recovery of all or any such Debt's Sum's of money  
 or Tobacco as aforesaid for me & in my name to Doe Execute & perform  
 as fully Largely & Amply to all intents & purposes as I myself might  
 or could doe if I were personally present with power of Constituting one or  
 more Attorneys under them as occasion shall require if they shall see  
 things fit and the same at their Wills & pleasures to revoke Ratifying  
 and Confirming allowing & holding firm & shall by these presents  
 whatsoever my said Attorney Thomas Greenfield or in case of his  
 disease disability or departure out of this Province as aforesaid the  
 said James Keeth shall lawfully doe or Act in the premises In  
 Testimony Whereof I have hereunto sett my hand & Seal this eighteenth  
 Day of June in the second year of the Dominion of Charles Absolute  
 Lord & Proprietary of the Province of Maryland & Avalon Lord Baron  
 of Baltimore & Churcho's Down 1677

 I say pay to M<sup>r</sup> James Frisby or his Order the sum of Sixty and ninety  
 pounds of Tobacco I place it to the proper demands
