tive unto at this present especially moving have assigned ordained made authorized
constituted and appointed and by these presents in my stead and place doth appoint ordain
make authorize constitute and appoint my dear and well beloved son John Comant
of Market Rasen in now England aforesaid to be my true sufficient and lawfull attorney
having by these presents granted unto him my said attorney full power and lawfull
authority for me and in my name to my use and upon safe possession
of emory all and singular the Plantations lands houses tenementes
sover with the rights incidents thereto to let and to have and to enjoy the same or any part
longing that are situated and lying in any part or place of Virginia or Maryland
or in any other part or place within the dominion of his majesty the king of England
where now do or hereafter shall or may belong or appertain unto me as I am now
feared of my satisfaction or otherwise howsoever else and every person
that do or shall or may lawfully occupy and possess and enjoy the same or any part
thereof to reposse and seize from thence etatis pennis or any part or place
for me and in my name to grant bargain sell lett and lease to me or persons
and for sure estates for lives feitorante or otherwise and for sure sume and sumes of
Money as to my said attorney shall be thought fit and requisite to the uttermost cost
expences and profit for me the said Elizabeth Comant et al the debts and debts of the same
Grants and Estates set to me made for me and in my name to seal and has my deed to
deliver unto the party or parties to whom the same shall be set made or to any other use
or uses whatsoever and counterparts of the same for me and in my name to accept and
receive also for me and in my name and to my use to demand sue for levy require
recovery execution of all and every person and persons whatsoever all and every sume debt
debt sume sumes of money rents and arrearages and remainders of rents or otherwise
whatsoever where it do or hereafter shall be due owing belonging or pertaining unto
me either for out of or by the above mentioned Plantations et al or any other wayes or
means whatsoever et al for default of payment and delivery of the said debts et al or otherwise
withholding or detaining the same to sue arrest attache imprisonment and torment
or their bodies goods et al in execution to take and out of execution to deliver and when
the said debts or et al to retton amount compounde compound and agree as the matter
shall require and upon composition satisfaction receipte extreame acquittance or otherwise
sufficient discharge in due form of law to make seal and deliver ALL DULY WITNESS
in and concerning the pennis and the debts and the same to be delivered and
made and done by due course of law or otherwise as fully effectually to all intent and
purpose as I might or could do personally present with power to substitute out or
more attorneys under whom my said attorney will have or limited power and the same
again at pleasure to revoke ratifying allowing and holding firm and stable all and
whatsoever my said attorney shall lawfully do or cause to be done in and about the
pennies by virtue of these presents fully witness whereof the said Elizabeth Comant have
hereunto set my hand and seal the twenty second day of September in the year
one thousand six hundred eighty four et anno regni Karoli secundi viiiij et modi
