

Manufacture of Europe as should be imported into any of them from
any other place whatsoever by land or by water and if by water or
by ship or barge in which they were imported with all the Gunnis Cattle
furniture ammunition and apparel our third part to his said Majestie
his heirs and successors our third part to the Gouvernour of Sore
lands Island Plantation & Colony territory or place into which same
goods were imported if the said ship or barge or goods be then seized or
informed against and sued for or otherwise that third part also to his
said Majestie his heirs and successors and the other third part to him
or them that should seize Inform or sue for the same in any his Majestie
Courts in Sore the said Lands Plantations & Colonies Territory
or placed where the offend was committed or in any Court of Record in
England by Bill Information plaint or otherwise wherein not shewing
protection or wages of same should be allowed And further that whom
as in the said Statute made all the same in and place aforesaid It
was enacted for the better prevention of frauds that from and after
the said twenty fifth day of March 1664 every person importing by
land any goods or commodityes whatsoever into any the said Lands
Islands Plantations & Colonies Territory or places should declare to
the Gouvernour of Sore Lands Plantation & Colony Territory or
place or to some person or officer as should be by him therunto
Authorized and appointed within four & twenty hours after such
Importation his and their names & dimensions and a true inventory
particular of all such goods & commodityes And not ship or vessel
returning to any Sore Land Plantation & Colony Territory or
place should load or unload any goods or commodityes whatsoever until
the Master or Commander of the Ship or vessel should first have made
known to the Gouvernour of Sore Land Plantation & Colony
Territory or place or to some person or officer as should be by him thereto
authorized and appointed the arrival of the said ship or vessel
with his name and the name and surname of the master and demand
and had shewre to him that he was an English Built Ship or made
goods by producing same certificate as aforesaid that she was a
Ship or vessel bona fide belonging to England Wales or the County of
Bermud upon Earth and navigated without English Master and
three fourths of the Marryards at the least English men and had
delivered to the Gouvernour or other person or officer a true and perfect
Inventory or Return of Sore together with the place or places in which
the said goods were laden and cast into the said ship or vessel under the
pain of the loss of the ship or vessel with all the Gunnis Cattle furniture
and apparel and of all such goods of the growth production or manufac-
ture of Europe as were not bona fide taken in and sold in England Wales
or the County of Bermud upon Earth to be recovered and divided in manner
aforesaid as in the same Statute is more fully contained All which shall be
said Goods sent arriving in this place of Maryland upon the twenty fifth
day of August instant and coming to an anchor in the port of Baltimore
in the County of Baltimore in the said Province of Maryland within the
Jurisdiction of this Court and then and there riding at anchor and
knowing the said Statute to be full force and irrepealable but the same
Statute
