 hand payed before the custaling and delivery hereof by Phillip
 Lynce of S^t Maryes County in the said Province of Maryland
 Merchant of whiche summe wee doe hereby severally acknowledge the receipt
 (that is to say) of the said Nehemiah Blackstone for the use of his
 Maj^{ties} share thirtie eight pounde six shillings and eight pence for
 his Maj^{ties} thirtie part for the ship Quind tackle apparell and furniture
 and wee the said Henry Varnall and William Digges have received
 thirtie eight pounde six shillings and eight pence for the use of the said
 Lord Prop^y. Christ Governour aforesaid for his thirtie part and also
 the said Nehemiah Blackstone have received the other thirtie eight
 pounde six shillings and eight pence for my thirtie part as presented
 according to the Act of Parliament aforesaid Wee the said Nehemiah
 Blackstone Henry Varnall and William Digges have bargained
 and sold and by these presents doe bargain and sell unto the said
 Phillip Lynce the said ship formerly called the friends Adventure
 now called the Blessing and all and singular the Quind tackle Ammu-
 nition furniture and Apparell to the same belonging or of right
 apperteyning and all our severall interests in the same by vertue
 of the Excommunication aforesaid To have and To hold the said ship and
 all and singular the Quind tackle Ammunition furniture and Apparell
 to him the said Phillip Lynce his Executors Adm^{rs} and Assignes
 To his and their owne proper use and use for ever In Witnesse whereof
 wee have hereunto sett our hands and sealed the 20th day of July
 16 Annoq³ Domini 1686
