 part thereof off any acquittances or discharge to make & deliuer that is to say the
 said Robert Brooke doo hereby authorize and appoint that the sume off thirty pounds
 sterling annuum to be payd for the Land aforesaid shall be payd Layd out and Expended
 by my said attorney for & towards the future Maintenance schooling and Education
 off my said two Brothers the said Ignatius and Mathew Brooke aforesaid from
 the time off the ^{first} payement off the said thirty pounds annuum But in case either
 off my said Brothers should dye before the full payements off the said severally yearly
 payements be finished then the said Henry Darnall to be accountable to me for the
 off the said thirty pounds sterling or so much thereof as shall Remaine due the
 maintenance schooling and Education off my Brother so dyeing being deducted and
 in case my said ~~two~~ Brothers should both dye before the said yearly payements be
 finished that then my said attorney to be accountable to me for the whole thirty pounds
 sterling annuum or so much thereof as shall upon their decease remaine due after
 their maintenance schooling & Education deducted as aforesaid, and whereas I have
 Received from my said father in Law an account that there is due to me for my childs
 part off the personall Estate off Thomas Brooke Late off Calvert Countij Geor^{ia} Deced
 the sume off twelve thousand pounds off Tobacco as also the sume off twenty five pounds
 off Lawfull mony off England I doo here by desire my said father in Law to keep the same
 in his hands untill I have occasion to call the same out off his hands and whatt my
 said father in Law shall Lawfully act and doo in the premises, I doo hereby
 promise to ratify & Confirme in as full Large and ample manner as if I myselfe
 were personall present according to the true intent & meaning off these presents, In
 Testimony where off I have hereunto sett my hand & seale this Twentieth day off July
 in the second year off the Reigne off our Souverainge Lord James the second off England
 Scotland France & Ireland King Defender off the faith De Annoq^{ue} D^{omi}ni 1636
