 and administrators and his and their Lands goods and Chattles for & by reason
 off the Entering into off the above recited bond and for Divers other good
 Consideracions him thereunto Moving hath given granted bargained sold
 aliened and Confrmed and by these presents doth give grant bargain sell
 alien and Confirme to him the said Edward bye his heyres & assignes
 All that tract of land or parcell off Land now Called Jusque hamough at
 New Comaught mannoe Lyeing in Cecil County aforesaid beginning att
 the furthest and uppermost source and fontaine head off Northeast River
 now Called Shenon River from thence cutting and bounding as followeth
 Vizt by a Lyne drawne Northwest till it intersect Oloraro River then by
 the said river till it fall into Jusque hamough River and by that River
 to the mouth thereof from thence by the head off the bay off Chespiow
 to the mouth off Northeast or Shenon Rivers and by the said river
 to the head thereof conveyning by Estimacion thirtij two thousand acres be
 more or lesse together wth all houses Ediffies buildings profit and
 Commodities to the same mannor and premises belonging or in any wise
~~ought to have off in or to the same mannor~~ ~~apperteyning~~ ~~and all~~ ~~rights~~ ~~and~~ ~~demands~~
 and Demand wth hee the said George Talbot now hath may might should
 or in any wise ought to have off in or to the same mannor & premises
 and all writings Grants & Evidences touching the same To have and to
 hold the said thirtij two thousand acres off Land mannor & premises
 aforesaid with their and Every off their appoyntments to him the said
 Edward bye his heyres and assignes to the only & proper use and
 be boofe off the said Edward Bye his heyres and assignes for ever and
 the said George Talbot doth for himselfe his heyres Executors and admini
 strators promise grant and agree to and with that said Edward Bye his
 heyres and assignes by these present that he the said George Talbot his
 heyres and assignes shall and will at all tymes here after for and
 during the Terme off seven years next Ensweing the Date off these
 presents doo make acknowledge Execute and suffer or Cause to be made
 done acknowledged Executed and suffered all and Every such further Law
 act & acts thing & things Devise and Devises Conveyances and assurances
 the Lawd what soever for the further and better assuring the said man
 Lands & promises to the said Edward Bye his heyres and assignes
 ever as by the Councell off the said Edward shall see reasonably devised
 advised or required PROVIDED never the lesse and it is the true
