

Witneseth That I. hester Bridger Sole Executrix of the Last will and Testament of My Late decessed husband Old Joseph Bridger as well in behalfe of the decedent as my own and in both our behalves have acknowledged and by these presents doo acknowledge and Confirme the givinge Graunteing of the said deed of Graunt together withall Lands and tenements with all other appurtenances thereunto Belongeinge or any wise appurtenaing unto Thomas Jones his heires and assigns for Ever and for better Confirmation of the same: bee it knowne unto all Men by these presents that I. hester Bridger aforesaid as well in the Ex of the Last will and testament of Joseph Bridger decedent aforesaid as well in the Behalfe of the decedent aforesaid as my own and in both our behalves doo make ordaine constitute and appoint my well Beloved friend the hono William Stevens Esq. to be my true and Law full attorney for me and in my name head and place as I am quallified aforesaid to acknowledge and Confirme the aforesaid Land and all and Every the appurtenances thereunto Belongeing or any wayes appurtenaing to be the Proper and reall Estate of him the said Thomas Jones his heires and assigns for Ever free and Clear from the Claims & Claimes of vs or Either of vs or heires or Either and Every of ours Executors & administrators or any person or persons Claiminge or pretending to Claim any Right title or intrest unto the aforesaid premises further. I doo in power my said attorney being quallified as aforesaid for the better Conveying and fure Making over of the aforesaid Land and premises to be the proper and reall Estate of him the said Thomas Jones his heires and assigns for Ever that my said attorney shall Confesse and acknowledge any further or better assurances as the Law of that Country doth require or any of the aforesaid Thomas Jones, the better Couill in the Law can devise advise or require and what my said attorney shall act or doo in the premises I. the said Hester Bridger Ex as aforesaid doo by these presents ratifie and Confirme and allow of Robt as firme and as good and Vallid in Law to all intents and purposes as if I.
