firmely by these p^{re}sents, Sealed with my seal Dated the Eighth day of Aprill Annoq^{ue} Domⁱⁿⁱ 1687.

The Condition of this p^{re}sent above written Obligacon is such, That if the above bounden George Thompson
his Heires Exec^{utors} & Adm^{inistrators} & every of them shall & doe from time to time & att all times foreuer hereafter
well & truly observe, performed fullfill & keep all & singular the Covenants grants Articles Clauses and
Agreements mencioned Contained & Expressed in one certaine Indenture of bargaine & Sale, or feoffment
bearing even date with these p^{re}sents & made betwene the above bounden George Thompson of the one
part, & the aforesaid John Brome of the other part, which on the part & behalfe of the said George
Thompson his Heires Exec^{utors} & Adm^{inistrators} & every of them are & ought to be observed performed fullfilled
& kept, and that in & by all things according to the true jntent & meaneing of these p^{re}sents Respectively
in all points & Condiocions, that then this p^{re}sent above written Obligacon shall bee void & of none
Effect otherwise shall stand & Remaine in full power force strength & vertue.
