Compound Conclude Agree & determine any difference upon Recoverie and Receipt to give Acquittances Releases and discharges in due forme and if need be to appear. And the persons of the said Constituants to Represent in any Court or Courts. and before all Lords Judges & Justices there to answer defend and Reply in all matters Causes touching or concerning the premises to coc. say pursue Implead arrest Seize Sequest. attach Imprison and to Condemn and out of Prison again to deliuer & Generally to use all Lawfull wayes and means for the Recoverie thereof either by Courts of Law or otherwise. as fully & amply to all intents & Purposes. as they Constituants themselves might or could doe if personally present with Power to substitute one or more attorneys under them or either of them & the same againe to Revoake They Constituants promising to hold for forme & valid all & whatsoever the said attorneys or either of them or either of their Substitutes shall Lawfully doe or Cause to be done in & about the premises by virtue of these presents.
