

Know all men by these presents that I Francis Hill of St Georges Hundred in the County of St Maries Planter being now banished for England & proposing special trust & confidence in my wellbelov'd friends John Wynne of St Maries County Surgeon & Peter Watts of the said County Planter have devised constituted & appointed by these presents our & quite constitute appoint in my stead and place with the said John Wynne & Peter Watts to be my true & lawfull Attorneys jointly & severally to act & doe & transact & manage all & singular my affairs in the said Province of Maryland, with full & absolute power for me & in my name all & singular the lands & Plantations belonging to me the said Francis in Maryland aforesaid to sell & dispose & conveyance or conveyances thereof to make Seals & deliver and the same in Court to acknowledge as fully & to all intents & purposes as if I the said Francis were then & there personally present to doe & performe the same with like full & absolute power for me & in my name but to my use the said Plantations & Lands to be sold sett or lett as they shall thinke best of the Stock of Cattle hogs & hoggys & household stuff & goods to sell & dispose at pleasure, also any Debt or Debts that are or shall be due unto me the said Francis within the said Province my said Attorneys or either of them the said Debtors for me & in my name but to my use to sue in my name & prosecute my Debt to recover & their goods & Chattells to serve or their persons for the same in prison to putt, & the same upon payment or composition to discharge at pleasure & release or releases for me & in my name to make Seals & deliver, & for the more full & doing of all & singular the things giving power unto my said Attorneys or either of them our Attorney or more under them to constitute & appoint of the same againe at pleasure to revoke & giving unto my said Attorneys & either of them my full power full strength & authority to act & doe all & singular the things & every or any of them in my absence & amand as if I my self were in the said Province of Maryland personally present to act & doe & performe the same hereby ratifying confirming allowing & allowing for good forme substantiall & effectual in the Law all that my said Attorneys or either of them shall doe or cause to be done in the premises or any of them In witness whereof I have hereunto sett my hand & Seale the seventh day of July in the year of Our Lord God One thousand six hundred Seventy seven.
