

This Indenture Made the Eighteenth Day of June in the Thirteenth year of the
 Dominion of the Right Hon^{ble} Charles Absolute Lord and Prop^{ty} of the Provinces of Maryland
 Avalon Lord Baron of Baltimore &c And in the year of Our Lord God One Thousand six
 hundred Eighty & Eight Betwene John Willson of the County of Ann Arundell in the Province
 of Maryland Planter of the one Part And Job Evans of the same County & Province Planter
 of the other Part Wittneseth that the said John Willson as well for^t in Consideracion of the
 full and Just sum of Eight Thousand Pounds of Good sound Merchantable Tobacco in Laske
 to him in hand (by the said Job Evans) already Paid & delivered or secured to bee Paid and
 Delivered of the Receipt whereof hee the said John Willson doth hereby acknowledge and
 therewith to be fully Contented Satisfied & Paid and thereof & Every part and parcell thereof
 of the said Job Evans his Heires Execut^d Administrators & Assignes & every of them doth acquit
 Exonerate & for ever discharge by these Presents As alsoe for divers other good causes & Valluable
 Consideracions him therunto likewise & Especially moving Hath Given Granted Alie ned
 Bargained Sold Enfrofled & Confirmed And by these Presents doth for himself & his
 Heires fully Cleerly & Absolelutely Give Grant Alien Bargaine Sell Enfrofle & Confirme
 unto the said Job Evans his Heires & Assignes for ever All that Tract or Parcell of Land called
 and knowne by the name Elerton, lying in Talbot County in Greate Choptank River on the
 Northeast Branch of the River on the East side of the brinch att the Mouth of a Creeke called
 Wattses Creeke or Wates Creeke on the South side of the said Creek Begirunge att A marked
 Cader Tree on the water side & Runing from the said Cader East & by North One Hundred &
 Sixty acres to a marked Oak in the Woods bounde^d on the South froth the said Oak by a lyne
 Drawne South & by East for the length of three Hundred Twenty five acres Bounde^d on the
 west from the en^t of the aforesaid Lyne by a line drawne West & by South One Hundred &
 Sixty acres to a marked tree by the watters side bounde^d on the North with the aforesaid Branch
 till it intersect with the first marked tree Containing & formerly laid out for Three Hundred &
 fifty Acres more or less Together with all the Trees Woods Underwoods Timber & Timber Trees
 Fruite Trees And all the Mesnages Tenements dwelling houses Tobacco Houses Out houses Barns
 stables Edifices Buildings fences & fencings orchards Gardens yards Back sides wayes Passages
 water & water Courses Benefitts Profitts Commodities Advantages & priviledges And alsoe all the Right
 title Estate Interest vse Possession Reversion & Reversions Remainers & Remainers of in & to the
 Premises & Every Part & Parcell thereof And Likewise all the Deeds Pattents Writings and
 Minuments which doth in Anywise Touch or Concerne the same with all & Singular other the
 Priviledges and Appurtenances therunto belonging or in any wise Appertaining (Royall Mines
 only Excepted) To have and to Hold all the aforesaid Tract or Parcell of Land & Premises
 with all and Singular the Priviledges & Appurtenances therunto belonging or in any Appertaining
 and Every Part & Parcell thereof unto him the said Job Evans his Heires & Assignes for ever
 to the only Proper vse & behoofe of him the said Job Evans his Heires & Assignes for ever And
 hee the said John Willson for himself his Heires Ex^d & Adm^d & Every of them doth Covenant
 Promise & Grante to & with the said Job Evans his Heires & Assignes & Every of them by these
 Presents That hee the said John Willson Now at the time of the Enscaling & delivery hereof is &
 standeth Seized in his Demaine of free Simple to him & his Heires of in & to the aforesaid parcell
 of Land & Premises & Every part & parcell thereof with th'Appurtenances and that hee the said
 John Willson Now hath in himselfe Good Right full power & Lawfull Authority to Give Grante
 Alien Bargaine Sell Convey & Assure the before Mencioned to be hereby Bargained Land and
 Premises & Every parte & parcell thereof with Every Shapp^t unto him the said Job Evans his
 Heires & Assignes for ever and that the Land & premises before mencioned to bee hereby Bargained
 and Every pt & Parcell thereof with Shapp^t Now are And soe shall & may for ever hereafter
 Remaine Continue & bee unto the said Job Evans his Heires & Assignes for ever free & Cleare And
 fully freely Cleerly & Absolelutely Acquitted & for ever discharged of & from All & all manner of
 Incumbrances whatsoever the Rent & Services which shall hereafter become due & payable unto the
 Cheife Lord or Lords of the ffe or ffs of the said premis only Excepted & forcpined And that hee
 the aforesaid Job Evans his Heires and Assignes the before Mencioned to bee hereby bargained lands &
 Premises & Every part & Parcell thereof with Shapp^t (as in manner & forme in & by these presents
 is mencioned & Expressd & According to the true Intent & Meaning of the same) shall & may for
 ever hereafter Peaceably & Quietly have hold vse Occupie Possesse & Enjoy & keep the same without
 the late suit Trouble Molestacall Eviction deniall or any hinderance or disturbance of him the said
 John Willson his Heires Ex^d Adm^d or any other person or persons whatsoever and further hee the
 said John Willson for himself his Heires Ex^d & Adm^d doth alsoe Covenant promise & Grante to
