Which being read and by the Court understood, it was by the said Court considered that the Power in the Letter of Attorney from the aforesaid Edward ~~and Dudley~~ Carleton to the said Thomas, was a sufficient Power for the said Thomas & Davies to give a full & Legall discharge to any Person whatsoever on the Account of the said Edward & Dudley Carleton of London Merchants.

Maryland^{ff}: Richard Mansham, John Hance and Sarah Warring Executors of Brasill Warring late of Calvert County deceased were attached to answer unto Edward Carleton & Dudley Carleton of London Merchants of a Plea of Trespasse upon the Case.

And whereupon the said Edward & Dudley by Anthony Underwood their Attorney Complaine that whereas the said Brasill Warring in his life time & to witt the fiftenth Day of December one Thousand Six Hundred Eighty & seven & stood indebted unto the said Edward & Dudley in the Summe of four hundred & and seauenteen pounds seauen shillings and one penny for a Cargoe of goods Consigned to the said Brasill in his life time by them the said Edward & Dudley as by the Invoyses hereunto Annexed may appear and likewise the one & Twentieth Day of Octob^r one Thousand six hundred Eighty and eight stood indebted unto the said Edward & Dudley in another distinct Summe from the former of five Hundred forty six Pounds eight shillings and seauen pence for another Cargoe of goods Consigned to the said Brasill by the said Edward and Dudley as by the second Invoyses hereunto Annexed may appear, as likewise in the Summe of nine Pounds fifteen shillings ~~and six pence~~ sent by the last Cargoe the not included therein, as also in the Sum. of thirty six pounds & seauen shillings and four pence for three servants sent along with the first Cargoe aforesaid amounting in all to the Summe of one Thousand & Tenn Pounds Two shillings & four pence, in Consideration whereof the said Brasill did assume upon himselfe, and to the said Edward & Dudley faithfully promise, that hee the said Brasill to them the said Edward & Dudley a just & true account of the said Cargoes, Bedes, & servants when thereunto required, would well & truly render, and the said Edward and Dudley doe in fact say, that trusting to the faithfull promise & assumption of the said Brasill in his lifetime to witt the dayes and yeares aforesaid did Consigne to him the said Brasill the said two Cargoes Bedes, and servants amounting to the said Summe of 1010^l: 2: 4, which said Cargoes, Bedes, & servants by Consignment of the said Edward & Dudley, were received by the said Brasill at Patuxant River in Calvert County, aforesaid, the respective &c
