Whereupon it is this day (to wit) the Nineteenth day of January in the Year of the Dominion of the R: hon: Charles & Co:
annno domini 1688 Considered by the Court here that the said Edward Carlton and Dudley Carlton Recover agt Richard Marsham,
John Hance and Sarah Warren recd of Bazzell Warren all the goods and merchandizes as is above mentioned in the invoice
amounting to Eighty Nine Pounds, seventeen Shillings & three p^t of half penny New money, and altho Tobacco, as appears by a List
of hogheads recd of several Persons, and marked for acc^t of the said Edward Carlton and Dudley Carlton being in all forty
fif^t of Nett Seventeen Thousand one hundred & twenty and three p^t of Tobacco, and alfor all the bills and account due from
the several Persons mentioned in the List of debts due to the said Edward Carlton and Dudley Carlton, amounting in the wh^t
to the sum of One hundred Sixty Seven thousand twenty and seven p^t of Tobacco, and the said Defendants in mercy

And it is further considered by the Court here, that the said Edward Carlton and Dudley Carlton have no set off late agt the said
Richard Marsham, John Hance and Sarah Warren exec^d of Bazzell Warren decd by Reason, it has been made appear to this Court
here, that the said Richard Marsham, John Hance and Sarah Warren exec^d of the said Bazzell Warren, were always ready and
willing to Render, and give an acc^t of all Concerns, relating or belonging to the said Edward Carlton and Dudley Carlton
from the said Bazzell Warren: as by the affidavit of Thomas Greenfield, Francis Buxton and John Somer of relation therunto being
had before said Court more plainly and at large appear.

And it is also ordered by the Court here, that Richard Full the Clerke of this Court, have allowed him the sum of two thousand
and one hundred pounds of Tobacco, for satisfaction of his charge and attendance upon this special Court
