Whereupon it is this day (to witt) the Nineteenth day of January in the XIII<sup>th</sup> year of the Dominion of the R<sup>ty</sup> hon<sup>ble</sup> Charles the second anno<sup>no</sup> Domini 1688 Considered by the Court here that the said Edward Carleton and Dudley Carleton Receiver ag<sup>t</sup> Richard Marsham, John Kance and Sarah Warren Exce<sup>rs</sup> of Barrell Warren dec<sup>d</sup> all the goods and Merchandizes, as is above mentioned in the Invoice amounting to Eighty Nine Pound, Seaventeen Shillings three Pence half penny, and money, and all the Tobacco, as appears by a List of hoggsheads rec<sup>d</sup> of several Persons, and marked for acc<sup>t</sup> of the said Edward Carleton and Dudley Carleton, being in all forty five Tons of Nett Seaventeen Thousand one hundred Seaventy and three p<sup>ts</sup> of Tobacco, and also all the Bills and Accounts due from the several Persons mentioned in the List of Debt, due to the said Edward Carleton and Dudley Carleton, amounting in the whole to the sum of One hundred Sixty Seaven thousand Seaventy and Seaven p<sup>ts</sup> of Tobacco, and the s<sup>d</sup> Defendants in mercy

And it is further Considered by the Court here, that the said Edward Carleton, and Dudley Carleton, have no Cert of Suit ag<sup>t</sup> the said Richard Marsham, John Kance and Sarah Warren Exce<sup>rs</sup> of Barrell Warren dec<sup>d</sup> by Reason, it has been made appear to this Court here, that the said Richard Marsham, John Kance and Sarah Warren Exce<sup>rs</sup> of the said Barrell Warren, were always Ready and willing to tender, and give an acc<sup>t</sup> of all Concernes, relating or belonging to the said Edward Carleton and Dudley Carleton from the said Barrell Warren: as by the affidavit of Thomas Greenfield, Francis Buxton and John Toney relation therunto being has aforesaid doth more plainly and at large appear.

And it is also Ordered by the Court here, that Richard Full the Clarke of this Court, have allowed him the sum of two thousand and one hundred pounds of Tobacco, for Satisfaction of his Charge and Attendance upon this speciall Court
