

**This Indenture** made the fourth day of November Anno: Domini 1691: and in the third year of the Reign of our Sovereign Lord and Lady William and Mary King & Queen of England Scotland France & Ireland Between John Meeks of Hatchliffe in the Parish of Stepney at's Belm Heath in the County of Middlesex Pyruigion of the one part and Joh Addison of Botomack River in the Province of Maryland Gent of the other part **Witnesseth** That the said John Meeks for and in Consideration of the sum of Seventy pounds of Law full Money of England To him in hand paid at or before the enfealing and Delivery of these presents by the said John Addison The Receipt where of and himselfe therewith fully paid & satisfied Hee the said John Meeks Doth hereby acknowledge and there of and of every part thereof doth clearly acquitt Release and Discharge the said John Addison his heires Executors Administrators and Assignes and every of them by these presents  **hath** granted Bargained sold aliened Enfeoffed and Confirmed and by these presents Doth grant Bargaine Sell Alien Enfeoff and Confirme unto the said John Addison **All** that parcell of Land now or here tofore called s<sup>t</sup> Elizabeths or by what other name the same is called or Known Lying on the East Side of Pascattaway River about Eight miles from Pascattaway Creeke beginning at a marked oak now or late standing by the water side near an Ashen Swamp that boundeth the Land now or late of George Thompson and running North up the River for breadth the length of one hundred ninety & four perches to a marked pokicory standing by an ashen Swamp next the mouth of a Creek called s<sup>t</sup> Johns Creek bounding on the North with the said Creek and a line drawne East into the woods for the length of ffive hundred perches to a marked oak on the East with a line drawne South from the end of the former line untill you meet with the Exterior Line now or late of George Thompsons Land on the South with the said Land on the West with the said River containing and heretofore laid out for Six hundred Acres more or less Together with all houses Ediffies buildings Rights benifits and heriditaments what soever to the said Land and premises belonging and the River con and River con's Remainder & Remainders Rents Issues and profits of the said premises and of every part and parcell thereof and also all the Estate right Title Interest Inheritance property claim and Demand what soever of him the said John Meeks of in and to the said Land and premises and every part and parcell thereof Together with all Deeds Evidences and writings Concerning the same (Which said parcell of Land was here tofore granted unto the said John Meeks by and from Cecilius Lord and Prop<sup>t</sup> of this Province of Maryland and Aualon Lord Baron of Baltimore &c) **To hold** unto him the said John Meeks his heires and Assignes for ever as by Deed under the Great Seal of the said Province bearing date the six and Twentiyeth day of May Anno: Domini 1663: more appeareth **To have and to hold** the said parcell of Land and all and singular the premises therein before mencioned or Intended to be here by granted bargained sold Enfeoffed and Confirmed with their and every of their appurtenances unto the said John Addison his heires and Assignes for ever To the only proper use and behooff of him the said John Addison and of his heires and Assignes for ever **AND** the said John Meeks for himselfe his heires Executors and Administrators and for every of them Doth Covenant promise and Grant to and with the said John Addison his Ex<sup>or</sup> adm<sup>r</sup> and Assignes by these presents That the said John Addison his Ex<sup>or</sup> adm<sup>r</sup> and Assignes shall or lawfully may from henceforth for ever hereafter peaceably and quietly enter into have hold occupy and enjoy all and singular the said premises with Thappt<sup>s</sup> and Recieve and take the Rents and Profitts thereof to his and there owne use and uses without any Lett Suit trouble Eviction Recovery or Interruption of or by the sayd John Meeks his heires or Assignes or of or by any other person or persons claiming or to claime by from or under him them or any of them **AND** That free and clear and freely and clearly acquitted & Discharged of and from all former and other Bargain
