That this day to witt the Seaventh day of October in the fourth yeare of their Majestic Reign De Anno Domini 1692: Came the within Named James MacAhey before us whose Names are herunto subscribed two of their Majestic Council for the Province of Maryland and acknowledged the within written Indenture to be his act & Deed and the Land and premises therein mentioned to be the Right of the within Named Wm Harris his heirs & assigns for ever and at the same tyme Elizabeth the wife of the said James MacAhey did the same and further the said Elizabeth being by us secretly Examined out of the hearing of her said husband did declare That she did freely & voluntarily give up all & singular her right title & Interest of in or to the within mentioned pcell of Land & Premises neither being thereunto induced by any feare threats or displeasure of her said husband and they both requested that the said Indenture as their act & Deed might be Recorded in the Records of the Provinciaall Court for the Province of Maryland In testimony whereof wee have herunto subscribed our Names the day & yeare above said

This Indenture made the 17th day of September Anno 1692 Between George Thompson of St. Maries County in the Province of Maryland Gent of the one part and Barnabe Anchetill of the said County & Province Gent of the other part Witnesseth that the said George Thompson for and in Consideration of two pcells of Land the one called Anchetill formerly laid out for five hundred Acres of Land but upon Resurvey found to be but four hundred & forty Acres of Land the other pcell of Land called Anchetill Range containing fifty Acres of Land in both pcells being but four hundred and Ninety Acres of Land both which pcells of Land are on the East side of Chesapeake Bay in Talbot County on the North side of Choptank River and in Harris Creek and Anchetill Range Joyns upon and John Andersons Land To him the said Thompson sold & Delivered and Conveyed for them drawn and Delivered with two for twice upon the same by the said Barnabe Anchetill from him his heirs Ex^{ts} Adm^{rs} and Assigns for ever unto the said George Thompson his heirs Ex^{ts} Adm^{rs} and Assigns for ever Wherewith the said George Thompson doth hereby acknowledge and himself therewith fully Satisfied
