of bargaine & sale bearing date the 22nd day of Aprill 1692 made
to Edward Chilton of the sd Colony for one sot of land called Turkey
Point lying & being in Carroll County in the sd Province to be
had & Seale of me the sd Mottrom Wright to the end the same
may according to the Law & Customs of Maryland be entred among
and remaine on the Records of the sd Province or County &
