By this Publick Instrument of Procuration Bese it
knowne and manifest to all People That on the sixteenth day
of December In the third yeare of the Reigne of William & Mary
King and Queen of England &c Anno Domini 1691: Before
me Josiah Jones Notary & Tabellion Publick by royall authority admitted
and Sworne dwelling in this City of London and in the presence of
the Wittnesses after menconed Personally appeared John Shelton
Citizen and Sadler of London (to me Notary well knowne who hath
made ordained and in his stead and place hath putt and constituted and
by these presents doth make ordaine and in his stead and place doth
put and constitute George Plater Merchant and Collector of their Maj^{ties}
Customes at Potuxan in Maryland to be his true & Law full Attorney
Giving unto him full power authority and Speciall Charge for in the
name and to the use of him Constituent to ask demand leavy recover & receive
of and from Mathew Scarbrough of Maryland aforesaid Merchant and other
person and persons whatsoever in Maryland and Virginia or other of the
said places whom it doth or may of right concerne all and singular such
Sums and Summes of money debts Goods Wares Merchandises Effects and
things whatsoever as the said Scarbrough or any other person or persons
whatsoever in Maryland and Virginia aforesaid or either of the said places
now doth or doo and hereafter shall owe and be indebted to the said
Constituent Bese the arising by Judgment Bond Bill Book debt speciall
account Covenant Contract promise assignement of Goods or other wise
howsoever Nothing Excepted nor reserved Together with all Costs damages
and interest Also to Compound and agree by arbitration or other wise
and as occasion shall require and to account with and Demand and take
account of the said Mathew Scarbrough or any other person or persons
whom it doth or may concerne touching the promises of the Records and
Receipts Compositions and agreem^{ts} acquittances or other sufficient
part and in the name of the said Constituent to make subscribe seal and
deliver; and if need be to appear in all Courts and before all Lordes
and Justices there to defend answer and Reply to all matters and
causes touching the promises And to pursue implead seize Sequester attach
arrest imprison and to condemn and out of prison againe (when need
shall be) to deliver; Likewise to Attorney or more with like or limited
power under him to make and substitute and the same at pleasure to
revoke; and generally in and concerning the promises, and the dependence
thereof, to doo say transact and accomplish all and whatsoever the said
Constituent himselfe might or could doo personally although the matter
requied more speciall authority than herein is comprized the said
