presents Doth demise grant bargain sell and to farme let unto
the said Thomas Neale his Ex^{ors} Adm^{ors} and Assignes All and
duty Mynds Minerals Quarries Mines and ores Royall of Gold
and Silver and also all and all manner of Gold Silver ores
Silver Copper Tyn Lead or other Minerals & Mettalls whatsoe
and all ore or ores holding Gold or Silver or mixt with Gold or

Quarries ores and Mettalls of the said Charles Lord Baltimore
a well not holding Gold or Silver as holding Gold & Silver whether

Plantacon or Colony of Maryland in America or within the
Island Isles Ground Soyle bounds and Limits of the said
Provinces of Maryland or any of them or in any parts parts
of them or any of them with full & free Liberty Power and
