The condition of this obligation is such that if the above bounden John Addison his Executors or Administrators do or shall with any fault or default performe fulfill accompanie and keepe paye and singular the Covenants Grants Articles Clauses and Agreements whatsoever which are or shall be or their parts or parts to be observed performed fulfilled accompanie and keepe paye and or incurred in certain Articles of agreement made bearing date with these presents made between the said John Addison of the one part and the said Thomas Addison of the other part according to the true intent and meaning of the same then this present obligation to be void otherwise to be in full force

Know all men by these presents that I Richard Mitchell Merchant for certain good causes and considerations me therunto moving have do hereby name make ordaine appoint and in my stead place put constitute my trusty & loving friend John Deillon of the City of St Marys in the Province of Maryland to be my true & lawfull Attorney & assignee for me & in my name & to my use to take claim demand recover take & recover of & from any person or persons within the Province aforesaid all such sums or sums of Tobacco owing to me from any manner of person or persons within the Province aforesaid by bill account or any other lawfull writing whatsoever Giving & by these presents Granting unto my said Attorney all my plenary authority & lawfull power for Recovery & Receipt of any sum or sums of Tobacco owing to me as aforesaid within the Province aforesaid or any part thereof as fully & effectually as the Law & Customs of the Province aforesaid will permit & suffer as I my self might do being personally present & to take order Compound & Court & agree of in the premises And upon any Recovery composition or other agreement to Signe Seale & Execute acquittances or any other receipts or discharges for me & in my name And Attorney or Attorneys under him to make Substitute against all his pleases to Revoke Holding & allowing for firm & Effectual to all intents & purposes all whatsoever my said Attorney or his Substitutes or Assigns shall lawfully do or cause to be done in or about the premises by the virtue hereof In Witness whereof I have hereunto set my hand & seal the third day of May in the year of our Lord God our thousand six hundred & seventy eight
