To all people to whom these presents shall come Richard Eltonhead of Euton head in the County of Lancaster Esq: I do hereby certify that the said Richard Eltonhead for and in consideration of the sum of one hundred pound of lawful money to him in hand paid by the right honor Charles Lord Baltimore hath given granted bargain sold demise release and confirmed & by these presents doth give grant bargain sell demise release & confirm unto the said Charles Lord Baltimore (in his full and peaceable possession now being) and to his heirs and assigns for ever all & every the lands tenements hereditaments and plantations whatsoever of him the said Richard Eltonhead lying & being within Maryland in the West Indies together with their and every of their appurtenances & also all the State right title interest term claims and demand whatsoever of him the said Richard Eltonhead of in and unto the same in any wise & the Reversion & Reversions remain and remainors rents yearly and other profits privileges freedoms liberties & Immunities & to have and to hold the same unto him the said Charles Lord Baltimore his heirs & assigns for ever to the sole use proper use and behoofe of him the said Charles Lord Baltimore his heirs & assigns for ever and the said Richard Eltonhead doth hereby for him his heirs & assigns & Administrators covenant promise and agree to and with the said Charles Lord Baltimore his heirs and assigns that he & they shall and may for ever hereafter quietly & peaceably have hold & enjoy the aforesaid premises and every part thereof with out the least trouble or molestation of him the said Richard Eltonhead his heirs or assigns or any of them or of any other person or persons whatsoever lawfully claiming the same premises or any part thereof by from or under him the said Richard Eltonhead or his heirs in any wise In Witness whereof the said Richard Eltonhead hereunto set his hand and seals the tenth day of July Annoq: Regni Caroli secunde Augusti or: 22^o: Annoq: Domini 1693
