To all people to whom these presents shall come Richard Eltonhead of Eltonhead in the County of Lancaster Esq: & his wife the Greeting Know ye that the said Richard Eltonhead for and in consideration of the sum of one hundred pounds of lawfull money to him in hand paid by the right honorables Lord Baltimore hath given granted Bargain & Sale & released & released and confirmed by these presents done give grant Bargain & Sale & release & confirmed unto the said Charles Lord Baltimore (in his full and plenarie possession now being) and to his heirs and Assignes for ever all & every the Lands tenements hereditaments and plantacions wherofor of him the said Richard Eltonhead lying & being within Maryland in the West Indies together with their and every of their appurtenances & affec all the said right titles interest terms clayms and demand wherofor of him the said Richard Eltonhead of in and unto the same in any wife & the Roverton & Redworts remains and Remaynders yearly and other profits priuileges freedomes libertyes & Immunitiees therin to have and to hold the same unto him the said Charles Lord Baltimore his heires & Assignes for ever to the sole only proper des and behoife of him the said Charles Lord Baltimore his heires & Assignes for evermore and the said Richard Eltonhead doth hereby for him his heires Executors & Administrators renounce Promis and agrees to and with the said Charles Lord Baltimore his heires and Assignes that he & they shall and may for ever hereafter quittly & peaceably haue hold & enjoy the aforesaid premises and every part thereof without the let trouble or molestacion of him the said Richard Eltonhead his heires or Assignes or any of them or of any other person or persons wherofor lawfully clayming the same premises or any Partthereof by him or vnder him the said Richard Eltonhead or his heires in any wife In witness whereof the said Richard Eltonhead here to sett his hand and Seal the 10th day of July anno Regni Caroli 3d nine August or 1693 Anno Domini 1693
