

become due or payable or accruing unto their Majesties their heirs and Successors within the said Province of Maryland or any of the precincts or limits of the same with full power and authority to and for him the said Edward Randolph by all lawfull ways and means to cause to be Recorded and paid unto the proper Officers to their Majesties use all such Rent Revenue Duties and profits aforesaid as have accrued to their Majesties since the beginning of the said first war or shall hereafter accrue to their Majesties their heirs and Successors within the said Province of Maryland and have not been or shall not be answered satisfied and paid to the proper Officers to their Majesties use: To have and to hold the Deputyship or under Office unto the said Edward Randolph so long as to him the said William Blatwayt shall please and so by him thought fit. And the said William Blatwayt doth hereby require from the said Edward Randolph and the said Edward Randolph doth by this acceptance of this present Grant agree to and with the said William Blatwayt that as the said Edward Randolph shall come in every six months or oftner during which he shall execute the said under Office or be Deputy to the said William Blatwayt by vertue of this present Transmitt and send over to him the said William Blatwayt fairly written and by the said Edward Randolph under his hand and seal attested all such accounts as he the said Edward Randolph shall before that time have imported examined and rated and which have not been by him formerly transmitted and sent over to the said William Blatwayt of the Rents Revenue Duties and profits aforesaid and duplicates thereof by the next conveyance and shall at the same time certify and make known to the said William Blatwayt all such summs and summs of money if any sum shall be as he hath by the way of and means aforesaid caused to be recovered and paid to the proper Officers to their Majesties use and which have not been formerly certified and made known unto him the said William Blatwayt and shall in all and every other matter and thing relating to the said Office observe such Rules and Instructions as the said William Blatwayt shall at any time or times give or transmit unto him. And lastly the said William Blatwayt doth hereby Ratify confirm and allow all and every Act and Lett thing and things which shall be done and executed by the said Edward Randolph as Deputy and under Officer to the said William Blatwayt by Vertue of this present Grant and doth hereby Grant that they and every of them shall be of equal force and authority as if they had been done executed and performed by the said William Blatwayt in his proper person.
