This indenture made the tenth day of March in the fifth year of the Reigne of
our Sovereign Lord and Lady William and Mary by the grace of God of England
Scotland France and Ireland King and Queen Defenders of the faith etc. and
in the year of our Lord Christ One thousand six hundred and twenty and two
Between our said Sovereign Lord and Lady King William and Queen Mary
of the one part and the most noble Marmadate Duke of Devonshire in the Kingdom
of Ireland of the other part Witnesseth that their said most Excellent Ma-
jesty King William and Queen Mary for divers good causes and considerations
the unto moving of their especial grace certain knowledg and merrit more
hand given and granted and by these presents for them and their Successors
Do give and grant unto the said Marmadate Duke of Devonshire his Executors
Administrators and Assignes all and every such Wares Yettam Yettam Lagan
Goodes Dorehit Dorehit Bullion plate Gold Silver Coyne Barres or Piggys of
Silver Ingott of Gold Merchandize and other goodes and Chattells what soever
which at any time or tyme heretofore have been or at any time or tyme
hereafter shall be lost cast away wreckt or lost in or upon any of the
Rocks Shoals Shoaly Seas Rivers or Banks in America between the
Latitudes of Twelve Degrees South and forty Degrees North and
which at any time or tyme within Twenty years from and after
the date of these presents shall be taken up gotten or recovered by
him the said Marmadate Duke of Devonshire his Executors Administrators
or Assignes or by or their Agents or Substitutes other than any other
such Wares Yettam Yettam Lagan Goodes Dorehit Dorehit Bullion plate
Gold Silver Coyne Barres or Piggys of Silver Ingott of Gold Merchandize and
other goodes and Chattells which have been or shall be lost cast away wreckt or
lost in or upon any of the Rocks Shoals Shoaly Seas or Banks within Twenty
Leagues of the Island of Bermuda in America and which at any time or tyme
before the Twentieth day of June which shall be in the year of our Lord
One thousand seven hundred and one shall be taken up gotten or recovered
and other than and except such Wares Yettam Yettam Lagan Goodes Dorehit
Dorehit Bullion plate Gold Silver Coyne Barres and Piggys of Silver Ingott of Gold
Merchandize and other goodes and Chattells which have been or shall be lost
cast away wreckt or lost in or upon any of the Rocks Shoals Shoaly Seas or Banks
between the City or Town of Cartagena and the City or Town of Havana in
or between either of those two places and the City or Town of Havana in
America or within the space comprehended within these right lines drawn
or supposed to be drawn from any part of the said City or Town of
Cartagena to any part of the said Island of Jamaica and from thence to any
of the City or Town of Havana and from thence to the said City or Town
of Cartagena and which at any time or tyme within Seven years from
the thirtieth day of August One thousand six hundred and twenty two shall be
taken up gotten or recovered and other than and except all such Wares Yettam
Yettam Lagan Goodes Dorehit Dorehit Bullion plate Gold Silver Coyne Barres or
Piggys of Silver Ingott of Gold Merchandize and other goodes and Chattells
which have been or shall be lost cast away wreckt or lost in or upon any
of the Rocks Shoals Shoaly Seas Rivers or Banks within Thirty Leagues of
the Isle of Sable in America and which at any time or tyme within
