This indenture made the 27th day of Jan: 1692 and in the sixth year of our Sovereign
King and Lady William and Mary by the grace of God of England Scotland France &
Ireland Defender of the faith &c: Bartholomew Whiteborne of London Widow to Edward
Carters late of Virginia in America Esq: of the one part And Richard Leonard
Esq: of the other part in full and sole power in Maryland & plantations of the other part Whereas
Richard Leonard Esq: late and proprietor of the province of Maryland & a late
Lord Baron of Baltimore &c: by a grant under the great Seal of the Province
of Maryland Bearer the thirteenth day of Aug: Anno Domini 1668 (the signing of the
said indenture) did then by grant unto the said Edward Carters Esq: of Henry Woods
of London Merchant a tract of land lying on the East side of Chesapeake Bay
beginning at a marked Elm tree standing by a point upon a small rock called
the Rock and a great Marsh called the Great Marsh running South and
by West four the day for breadth five hundred fifties lot marked Oak by
the Bay side and South East by the Bay two hundred twenty & five fifties
of a marked Larch tree and South East and by South unto a marked Oak
bounding on the South by a line drawn East from the said Oak one hundred
and fifty fifties on the East by a line drawn North from the end of the said
line one thousand one hundred and fifty fifties on the North by a line drawn
West from the end of the North line unto a marked line tree on the West by the
said Bay containing and there laid out for two thousand three hundred
Acres more or less together with all Royalties and Privileges Royall Mines
excepted most usually belonging to Mannors in England Also for the Rent of fifties
the Bishopric of Virginia Mary and S: Michaels the Anchorage by Equale portway which
said tract of land was divided into a Mannor by the name of Norton Mannor
as in and by the said grant more of large may appear And Whereas the said
Edward Carters by a certain Statute made bearing date the twelfth day of
July 1697 was bound and firmly obliged unto Henry George and John
Holland in two thousand five hundred pounds which sum by a Deed
made in and about the said month of July 1697 was conveyed to be
paid for the purchase of the sum of twelve hundred pounds to the said
Richard Carters by the name of Elizabeth Long before her intermarrying with
the said Edward Carters by a Joyner for the said sum and her heirs
