

Statute for transferring uper into possession and to his heirs All -
 these several plantations belonging by Gift or purchase unto sundred
 persons (the said persons were or had been) lying and being in
 the said County of Calver in the County of Devon in the Province of
 Maryland, which said lands were the proper share of the said Richard
 Charlott Dorset and all his heirs and assigns, his buildings
 outbuildings, workhouses, woods, profits, commodities, ways, passages,
 inclosures and hereditaments, whatsoever depending or being in
 or upon or in any wise belonging to or used or enjoyed with all and every of
 the said premises together also with all and every the utensils, tools,
 implements and materials whatsoever belonging unto or upon or upon
 in about the premises or any part thereof All which said premises were
 by the said Will and Testament of the said Richard Charlott given and
 bequeathed amongst other things to the said John Charlott Katherine
 King Mary Saller and Francis Bryan, and also to their children
 other of the issue of the said Richard Charlott then was living at
 the time of the said making the said Will and said their
 Dorset without issue to be equally divided amongst them and all their
 right and title interests in the same property profits, revenues and demands
 whatsoever of them the said John Charlott and Mary by wife Richard King
 Katherine by wife John Saller and Mary by wife Nathaniel Bryan
 and Francis by wife or any of them or to the said Nathaniel Bryan
 plantations and all and singular other the premises therein before
 mentioned or of in or to any part or parcel thereof with their and every of
 their appurtenances by virtue of the said Will or otherwise whatsoever
 to have and to hold the said Nathaniel Bryan, all singular other
 the premises with their and every of their appurtenances unto the said Edward
 Charlton by him and assigns to the only use and behoof of the said
 Edward Charlton by him and assigns for ever And each of them the said
 John Charlott Richard King John Saller and Nathaniel Bryan for their
 parts and the respective heirs and for their several and respective heirs -
 Executors and Administrators severally and respectively and not any of them
 for and with the other of them or for the use or behoof of any other
 of them the said Nathaniel Bryan and all singular other the premises
 with their and every of their appurtenances unto the said Edward -
 Charlton by him and assigns against them the said John Charlott
 Mary by wife Richard King and Katherine by wife John Saller and
 by wife and Nathaniel Bryan and Francis by wife respectively and
 their several and respective heirs and assigns and against all
 every other person and persons lawfully claiming or to claim
 against them or any of them or by them or under the said Richard Charlott -
 bequeathed by the said Will and Testament and Will Warrant and for ever
 defend by their persons And the said John Charlott Richard King John
 Saller and Nathaniel Bryan do for themselves severally and for their
 several wives and for their several and respective heirs Executors and
 Administrators severally and respectively and not any of them for or with
 any other or others of them or for the use and behoof of the other
 or others of them Covenant promise and grant to the said
 Edward
