 Deed of Sale by the said John Nuttall the Receipt whereof was the said
 Thomas Sprigg and Ellice Sprigg parties to this present Writing or Deed
 both acknowledged and signed and of every part and parcel thereof and
 Honours and Distances the said John Nuttall by his own hand
 and every of them for ever by this present for and upon Divers Causes and
 good Considerations by Mordring hath given granted Bargained sold
 Imposed and confirmed and by this present both give granted Bargained
 sold and confirmed unto the said John Nuttall and by his own
 Assignes for ever all that parcel of Land being part of a parcel of
 Land purchased by the said Thomas Sprigg of and from Sir Thomas
 Pennally being part of the Reservation named and lying on y^e
 South side of the head of Back River running out of Puttapan
 River
