 Carter by virtue of the power aforesaid am for and in the name of his Said Thomas Francis party to these presents, and forth
 in consideration of full and just sum of money paid to him by Said Thomas Francis before Exchanging
 delivery of these presents in hand paid or delivered to said by him & Said Sam^l Young & receipt whereof and of every
 party and parcels thereto of Said Edward Carter doth hereby for and in behalfe of the Said Thomas Francis acknowledge
 and confess, and thereof and of every party and parcels thereto of hereby general acquitt and discharge him the said
 Sam^l Young his heirs executors and administrators hath given granted Bargained sold aliened Enfeoffed and confirmed as
 by these presents he doth give grant Bargain Sell alien Enfeoff and confirm unto him the said Sam^l Young all that
 Tracte parcell of Land before mentioned lying and being in Prince in Baltimore County as aforesaid by a Swamp called
 the Cranberry Swamp and beginning at a Bound or stake being a bounded line of a parcell of Land formerly laid out for
 George Yale Gent. called Betty's Choice, and running North East two hundred perches to a Bound or stake then North
 west three hundred twenty perches, then South west two hundred perches to the line of the said Betty's Choice, Then wth
 a straight line to first bounded tree containing and laid out for four hundred acres of Land more or less to have and
 to hold the said Tract of Land and premises, wth all and Singular its Rights members, and Appurtenances whatsoever
 therunto belonging unto him the said Sam^l Young his heirs and assigns for ever free from and clear of all manner
 of incumbrances whatsoever (he reserving hereafter to grow and to Right honest the Lord Proprietary of this our
 Province only excepted) All the said Thomas Francis by & Said Edward Carter his attorney doth for himself his
 heirs executors and administrators covenant promise grant and assign to the said Sam^l Young his heirs and assigns that
 the aforesaid Tract or parcell of Land and premises wth all and Singular the Appurtenances thereto belonging is at his
 own installing and delivery of these presents absolutely free and clear as well from all or any former grant
 Bargain Sale mortgage or incumbrance whatsoever had made committed or due either by the said Thomas Francis or any
 other person whatsoever as a good from running into any loss of any former or more ancient Survey and that the said Thomas
 Francis is at and before the delivery of these presents Seised thereto by a good friend and moste fauorable Estate in his
 hands, and hath full and ample right to sell and dispose of the same to the said Sam^l Young and his heirs for ever
 And further that he the said Thomas Francis the said Tract of Land and premises wth all and Singular the Appurtenances
 thereto belonging unto him & the said Sam^l Young his heirs and assigns for ever against all persons whatsoever that shall
 will for ever warrant and defend the Wills whereof the said Edward Carter by virtue of his power and authority soe
 as aforesaid granted herein his heirs and said Thomas Francis as his own hand and Seal

 Deliver a certaine Deed of Bargain and Sale of four hundred acres of Land lying in Baltimore County and
 Called Hollands Hill hereto granted to Thos: Francis my father and by right of inheritance to me
 unto Sam^l Young of Anne Arundell County gent the which and thereby making unto him & Said Sam^l Young
 and his assigns a good Estate in the same wth all such Conveniences Grants and Clauses as shall be thought
 by the Council Learned in Law of the said Sam^l Young better assurance of the said Land unto him & Said
 Sam^l his heirs and assigns for ever hereby Granting unto my said Attorney full and ample power and
 authority to act do and perform all manner of acts necessary to be performed towards vesting a Land and firm Estate
 in the said Sam^l Young & his assigns in my name according to the act of Assembly of
 this Province or otherwise, hereby ratifying and confirming what my said Attorney shall do in his premises and holding
 same as friend and officialem in all intents and purposes as if actually done and executed by my self In witness
 whereof I have signed Sealed and sealed this 29th day of December 1696.
