

By this Subscrib'd Instrument of Prouration or Letter of Attorney Be it knowne and  
 manifest unto all people that on the fourth day of September Anno 1696 and in the eighth Year of  
 the Reigne of William the third King of England before me William Scory Notary Publick  
 admitted and Sworn dwelling in London and in the presence of the witnesses after named  
 personally appeared Mr Gabriell Morel of London Esq<sup>r</sup> Gent and hath made ordain'd and Constituted  
 and by these presents doth make ordaine and Constitute Jacob Morel and Merchant now in  
 Virginia or Maryland his true and lawfull atty giving unto him full power and authority  
 for and in the Name and to the Use of him Constituant to Ask Demand sue for recover and  
 receive of and from Michael Miller and Richard Marsham residing in Virginia or Maryland  
 aforesaid or either of them their or either of their Heirs Ex<sup>ors</sup> or Adm<sup>ors</sup> all and singular such  
 Sum and Sums of Money Goods Effects Debawes and things what soever which the said Michael  
 Miller and Richard Marsham or either of them owe and are indebted to the said Constituant for  
 what cause or Reason soever the same may be nothing Excepted or Reserved w<sup>th</sup> all Costs Damages  
 and Intrests all so touching the saids Account or Accounts to be Settled and receive the balanc  
 and any Matter or thing in Difference to be Settled and determine by Arbitration or any  
 other Amicable Means and if needfull to Compand and agree upon records and receipts  
 compositions and Agreements to make and give due and sufficient acquittances and discharge  
 and if needfull to appear and the person of the said Constituant to represent in all Courts and before all  
 Lords Govern<sup>rs</sup> Judges and Justices and to pursue Imp<sup>ro</sup> Seiz<sup>es</sup> Replew<sup>ns</sup> Attach Arrest Imprison  
 and to Endemn and out of Prison againd whom need shall be deliver sum facultas Substitucio<sup>is</sup>  
 and generally in and concerning the saids and the Dependencies to doe say tranfact and accom  
 plish as well in Judgement Court as without what soever the said Constituant himself might or could doe  
 personally although the matter require more speciall Authority than he is empowered he hereby  
 promising to hold and ratify for good and valid what soever his said atty or his Substitutor shall  
 Lawfully doe or cause to be done in the saids by virtue of these presents In witness whereof the  
 said Constituant hath hereunto put his hand and Seal the Day and Year first above written in the  
 presence of John Ruck and William Brookhouse witnesses
