 therein. I the said Constable do hereby further Authorize & empower my said Attorney for me to  
 appear in all Courts, before all Justices, Judges, & Justices thereof to prosecute Implore seize Legation  
 arrest and Imprison, and to condemn at & by or any of the said person or persons whatsoever their  
 or any or any of their Goods & Estate and & said ~~Attorney~~ out of prison again when he or she shall  
 deliver & receive one or more to the like or limited power and authority to make & say and at his pleasure  
 to do and against and Generally in and concerning & promising & depending thereof to do say transact and  
 accomplish all and whatsoever in my self might or could personally do although the matter requires more  
 special Authority then herein is Comprehended having holding ratifying confirming & allowing of full good  
 and valid for ever all and whatsoever my said Attorney or his Substitutes shall Lawfully do or cause to be done
