County at Eastern Shore was cured both of the Yaws in three weeks time -- A Sinking Child of one Sarah Barnaby
living in St. Marys County was cured of a Fever & Aigue and the itch -- Jacob Taylors wife living in Chester River
in the County of Kent having a pain of her Limbs two Yeaers and especially one half year she could not go in her Bed was cured
in Twelve Days time -- Charles Skinner of the same place said same to her was cured of a pain in his Limbs
