These are therefore humbly to Certifie that by vertue of y^e aforesw^t: I have resurveyed y^e aforesw^t of
Land lying in Talbot County in y^e Person of the Sheriff & by Directions of a Jury of the vicinage for that
purpose by y^e Sheriff Summoned impannelled & sworn & according to the Evidence to them produced beginning
at the mouth of a Crooke Called dividing Crooke and on y^e South East side of y^e Crooke of five peches in y^e
water being y^e place doorned & taken by y^e Jury according to y^e Evidence to them produced, wheroy^e bound
Cedar mentioned in y^e plat of y^e Original Survey then north East three hundred & twenty peches then
North North West two hundred & ten peches then South West to the first beginning Containing four hun
dred & Eighty Acre no trespass does appear to lie y^e Jury to be committed or done on y^e said Land, all which Survey
