 by him y^e said Jacob Morland and all others whom it may or shall concern
 or them thereunto to Compell by all lawfull wayes & means whatsoever and
 to that end if neede shall appear all Lord Judges & Justices in any Court or Court
 there to answer defend & reply in all matters & causes touching or concerning
 y^e premises to doo saye & Impound seize & quater at each Imprison and
 to send out of prison againe to deliver & generally in & concerning y^e
 premises to doo performe & execute all & whatsoever shall be requisite & necessary
 as fully amply & Effectually to all Intents & purposes as they & the said Parliament might
 or could do if personally present the y^e said Parliament hereby promising to
 ratify confirm & hold for good & valid all and whatsoever the said James
 & George plater or y^e survivor of them shall lawfully do or cause to be done
 in or about the premises by virtue of this present Statute & passing London
 in y^e presence of Capt. W^m Hoare & M^r James Crooke and Thomas Morall
